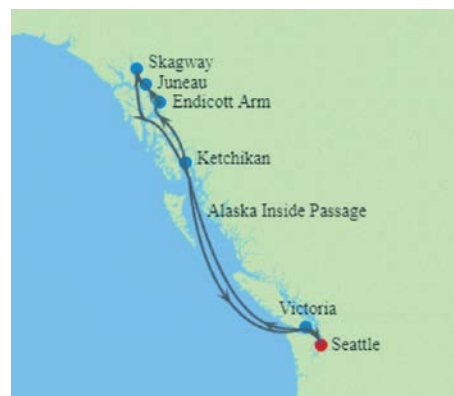

## General Conditions

**Deposit Requirements:** A deposit of \$300.00 (in US funds) is required to secure accommodations. Personal checks, money orders, and credit card (MC/Visa/Discover) payments are accepted. A second payment of \$1,000 per person is due by May 15, 2025. The final balance is due by June 5, 2025. Reservations made after June 5, 2025 will require full payment at the time of booking. Deposits may be made by personal check, money order, or credit card (Visa/MC/Discover). Credit card payments beyond the initial deposit will be accepted for an additional 3% non-refundable fee.

**Cancellations and Refunds:** All cancellation requests must be addressed to Templeton Tours in writing. Cancellation fees will be charged as follows:

- \$125 per person when canceled more than 95 days before sailing.
- 50% of cruise fare when canceled 94-65 days of sailing.
- No refund for no-shows or when canceled within 64 days of sailing.

Airline ticket cancellation is subject to the cancellation policy of the specific airline. In most cases tickets are non-refundable. Trip cancellation insurance is recommended.

**Identification:** All U.S. passengers are required to present proof of citizenship in the form of a valid passport, or a certified birth certificate along with a government issued photo ID such as a driver's license. For more information or to obtain a passport application, visit [www.travel.state.gov](http://www.travel.state.gov). Passengers denied boarding are not eligible for a refund. All non-U.S. Citizens should contact their respective embassies or U.S. & Canadian Immigrations for applicable regulations. Children under 18 years of age traveling without both parents must bring a notarized letter of consent from the absent parent(s), giving permission for them to leave the country with a specified adult guardian.

**Embarkation:** The Celebrity Edge sails from Seattle, Washington at 4:00PM on Friday, August 22, 2025. Embarkation begins at 11:00AM. You must be on board no later than 2 hours before sailing.

**Disembarkation:** The Celebrity Edge returns to Seattle, Washington at 6:00AM on Friday, August 29, 2025. Allow 1-2 hours for disembarkation, customs and immigration formalities.

**Fare Inclusive:** Your cruise rate includes ocean transportation, accommodations, entertainment, service and meals, gratuities for cabin steward and dining staff, and port charges. Prices are from Seattle, Washington in U.S. funds.

**Accommodations:** Prices are based on two full-paying passengers per cabin. Single cabins are available at 200% of the category price. Pricing for 3rd and 4th passengers in a cabin is available upon request.

**Cruise Baggage Allowance:** 2 medium suitcases, 1 carry-on bag per person.  
**Not Included:** Air transportation and transfers to the port of departure, optional shore excursions, and items purchased onboard.

**Disabilities/Pregnancy/Infants:** Celebrity Cruise Lines recommends that guests with disabilities complete a Special Requirements Information (SRI) form at the time of booking in order to prepare for the guests' arrival. Guests who are unable to care for their basic needs (e.g. dressing, eating, and attending safety drills) MUST have a capable traveling companion. Call Templeton Tours to request an SRI Form. Celebrity will not accept reservations for infants less than 6 months of age on the date of sailing, or women who have begun their 24th week of pregnancy at any time before or during the cruise. Please notify us if you are pregnant.

**Passage Contract:** The attention of the passengers is specifically directed to the conditions of transportation set forth in the passage contract of the ticket of Celebrity General Sales Agents and Operators. Celebrity reserves the right to alter the itinerary or substitute vessels if deemed necessary.

**Gratuities & Fuel Surcharges:** Gratuities for your cabin steward, waiter, busboy, and Maitre d' (est. \$126.00 pp) are included in the pricing. Templeton Tours reserves the right to pass along any increase in fuel surcharges imposed by the cruise line.
